Research Management Course Development

- Working group of ASUE consits of 2 persons in charge of Course development has been astablished.
- Draft is ready for discussion, comments and recommendations for improvement.
- During the development of the Course it was decided to go forward and develop 2 courses. One is full academic 3 ECTS course for PhD students and the second: short course for outreach program, LLL for wider public/academic community.


